Attachment A

Pastor Bill Sperry's Personal Statement of Faith

I believe in God, the great Composer and Conductor of our universal symphony. God is One and is the only eternal being, existing in the three persons of Father, Son, and Holy Spirit. As the great Composer, in an act of divine love and creativity, God created all life and all matter and set into motion events that will demonstrate love to God's creation, show the Lord's nature as sovereign ruler of all things, fulfill God's covenant promises, and express God's glory and praiseworthiness. This Composer created and maintains a masterpiece of will for the performance of the universal symphony. Each mood, line, measure, note, and accidental is known to its Composer; and by the Conductor's divine and graceful hand, the symphony will one day be played to perfection.

As Conductor, God has graciously chosen to allow humanity to participate as players in the great orchestra. Yet, in our idolatrous desire to steal the spotlight, we have strayed from the music God has written and have improvised in a way that is dissonant with the Composer's perfect score. Rather than casting us all from the orchestral pit, God sent Jesus, God's only begotten Son, to sit among us as First Chair. In his perfection, Jesus taught us how to keep our instruments in tune; how to listen to and appreciate our fellow musicians; how to interpret and follow the score; and above all else, how to enjoy, love, and obey the Conductor. Sadly, we misunderstood Jesus and failed to see that he was, in fact, the Conductor and Composer among us, both fully God and fully human. So, we rejected him and killed him. But, even death could not hold him; and after three days, he was resurrected to life to sit again at the right hand of the heavenly Conductor. His presence was a foretaste of the glory of the final performance, and he promised to return for an unparalleled encore. In great mercy, the Father accepted Jesus' death as an atoning sacrifice for our rebellion, providing eternal salvation for all those who repent and believe.

After Jesus' earthly departure, the Conductor sent another virtuoso, the Holy Spirit, to counsel, empower, and move among us. The Spirit maintains order and gives common grace to the pit. Though an advocate for all, the Spirit handpicks certain musicians to enjoy a personal relationship with God, a relationship that provides spiritual freedom and revelation in this life, as well as promising eternal participation in God's endless, heavenly symphony. Mysteriously, the Conductor does not choose musicians for salvation on the basis of exceptional talent or accomplishment. The Conductor's choices can only be understood as grace notes within His sovereign will and love.

Within the greater orchestra, those the Conductor chooses as believers are set apart to be the church, the Body of Christ, to serve as section leaders, representatives, and advocates of the Composer's original score. The church reflects the missional nature of the Conductor, so it must regularly seek opportunities to foster justice, model repentance, demonstrate mercy, and share the good news of God with unbelieving musicians. In practice, the church regularly recognizes and demonstrates God's covenant promises through the holy Sacraments of Baptism and the Lord's Supper, the signs and seals of those covenant promises. In Baptism, we recognize our own transition from spiritual death in sin to life in Christ, and we experience the cleansing from sin that is found only through Christ. Around the Lord's Table, we experience in covenant community the spiritual presence of Christ through the bread and cup, his body and blood given for the forgiveness of sin.

Finally, with each day that passes and each note I play (whether proper or errant), I enjoy a greater appreciation of the trustworthiness of the Composer and the perfection of the Composer's written score, God's word revealed through Scripture, the score inspired by God and without fallacy. On the basis of the promises provided by that divine score, I humbly labor in

response to God's goodness and await the eternal performance of the Composer's blessed masterpiece.

Personal Statement of Faith Geoffrey Stuart Kohler
