Our strategic planning "special" committee continues to meet and is working on finalizing our recommendations regarding the charge given to us by San Diego Presbytery. We are asking for an hour of docket time at the October Executive Committee meeting, as well as time on the docket at the November Presbytery meeting.

We recognize that we report to the Presbytery, and not Executive Committee, but we believe it is important for Executive Committee to hear our process, as well as the decisions we want to recommend to the Presbytery.

As was mentioned in our report to Presbytery in May, a lot of our conversations have revolved around leadership, new worshipping communities, property, and the vitalizing of existing congregations and how those issues tie into our vision and mission.
